South Nassau Communities Hospital offers a comprehensive range of standard and specialized health care services, curative, restorative, preventative and emergency medical care. In response to the diverse and growing healthcare needs of the communities we serve, South Nassau has expanded and enhanced many of its services and facilities. Here are just a couple:

CENTER FOR CARDIOVASCULAR HEALTH

In an emergency, when seconds count, South Nassau's Center for Cardiovascular Health averages a "door-to-balloon-time" of approximately 62 minutes when performing an emergency angioplasty, which is 28 minutes faster than the national standard door-to-balloon time benchmark of 90 minutes (Door-to-balloon time is the time measured in minutes from the moment the patient walks in the door to the point the artery in the heart is re-opened with a stent.) The center's performance and service excellence is second to none, as it has earned prestigious designations, awards and accreditations, including the Get With The Guidelines®-Heart Failure Gold-Plus Quality Achievement Award by the American Heart Association/American College of Cardiology Foundation and the Joint Commission's Gold Seal of Approval® for its disease-specific heart failure program.

EMERGENCY DEPARTMENT

South Nassau's Emergency Services Department is the busiest community hospital emergency services department in Nassau County, serving more than 65,000 patients annually. The department has over 35 large independent treatment bays as well as its own dedicated Computerized Radiology Suite for rapid access for testing and results. Designated a regional Stroke Center by the New York State Department of Health, the department is southern Nassau County's only Trauma Level II Center. The department is in the early stage of a \$60 million renovation that will nearly double its size to accommodate a projected 80,000 patient visits each year as well as establishing dedicated areas for behavioral health and pediatric emergencies.
