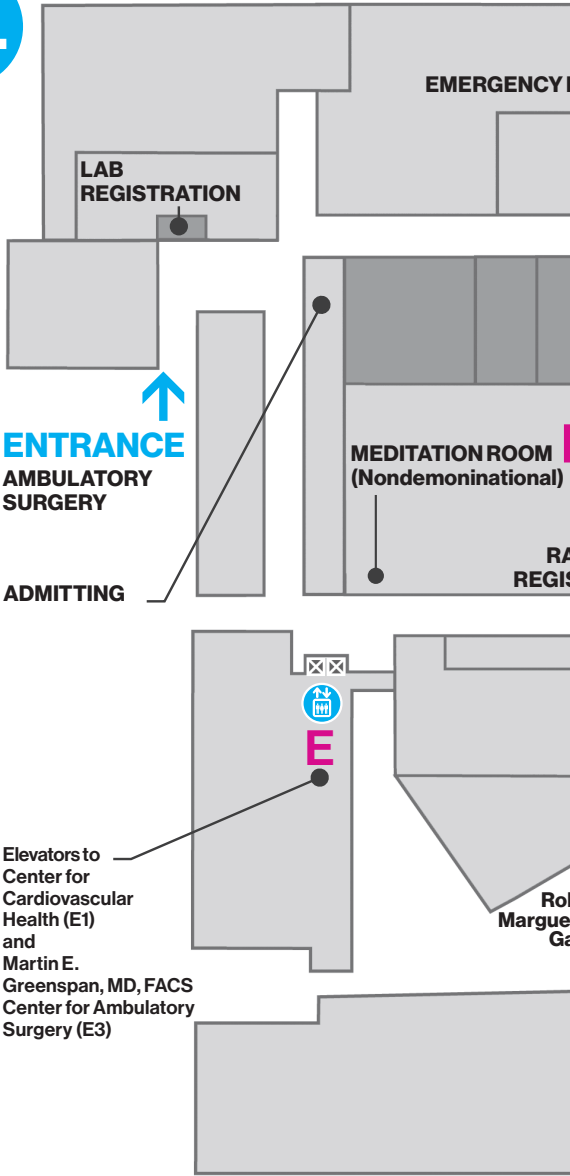

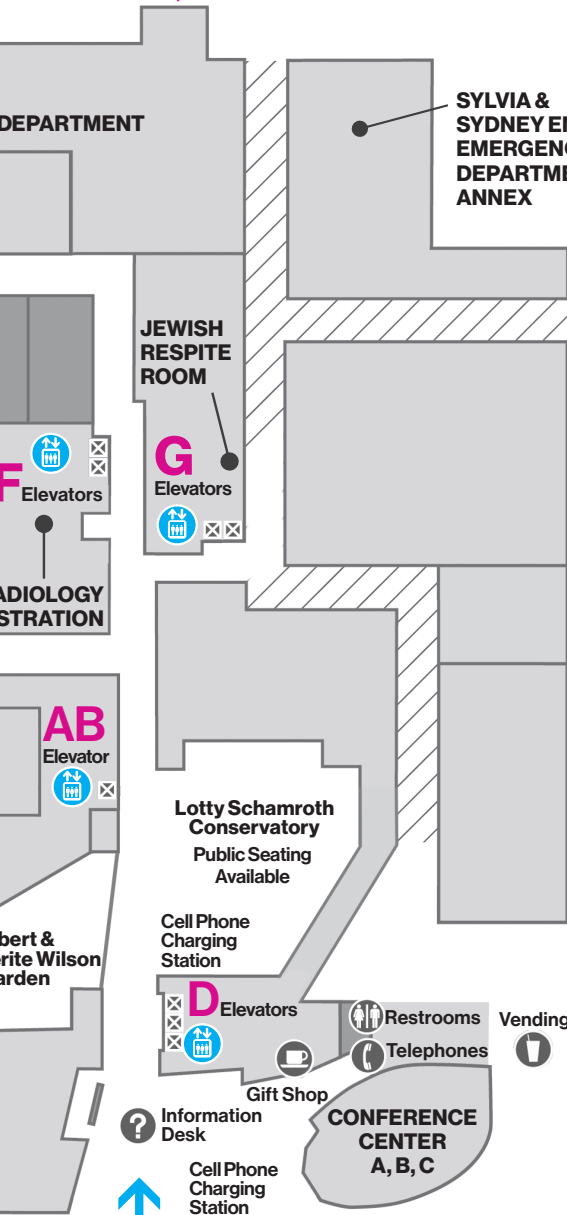

Visiting hours and policies

Mount Sinai South Nassau's visiting policies support our commitment to the patient's right to receive visitors at any time during their hospitalization, while maintaining a safe and secure environment for our patients, employees and visitors.

Visitors or support persons can have a positive impact on the healing process and quality of care. We will accommodate visitors to the best of our ability throughout the day, but urge you to keep in mind that patients often need a great deal of rest to recuperate. We also ask that you respect the needs and wishes of other patients.

Information for Visitors:

- Parking lots 2 and 5 are for patients and visitors only. Both lots utilize attendant-assisted parking. **Valet services are available** at the front of the hospital and at the ED entrance for a fee.
- A **free guest Wi-Fi** network is available throughout the hospital for patients and visitors.
- No photographs, cameras or video of any kind are permitted
- Please **keep voices low** and maintain a quiet and peaceful environment.
- Hospital staff may request or require that visitors leave a patient room temporarily.
- We ask that **during the hours of 6 am – 10 pm, that no more than two visitors** remain at the patient's bedside at any given time and **during the hours of 10 pm – 6 am, we request only one visitor** remain with the patient.
- Please **notify the nursing staff if you have a visitor who will remain overnight** so that we can make your visitor as comfortable as possible.
- **Children must be supervised** by an adult visitor and behave properly or the supervising adult will be asked to leave the unit with the child.
- **Any disruptive visitor will be removed** for the safety of all involved.
- **Visitors who are ill should not visit patients.**
- All visitors should **wash their hands frequently with soap and water**, before and after visiting, after trips to the bathroom, and after touching any item or surface that is soiled. All visitors should also **strictly adhere to any isolation precautions.**
